- the child lives in the parishes served by St Mark's Church on Bathurst Gardens and St Martin's Church on Mortimer Road (a map of the parish boundaries and a list of roads which fall within the boundaries are available from the School website or office); **and**
- your family regularly attend St Mark's, St Martin's or a place of worship of another Christian denomination or other world faith.

**Governors define regular attendance as physical attendance at a weekly service on at least 26 occasions in any period of 12 consecutive months falling within the two years preceding the application (services that are accessed online do not count for these purposes).**

In the event that the School is over-subscribed, this information will help the Governors decide if the application should be considered under over-subscription criterion D in the School's admission arrangements (available from the School website or office).

For this information to be considered:

- the **religious reference statement** must be completed, signed and stamped by the relevant religious leader. Please provide additional statements if you would like attendance at more than one place of worship to be taken into account; **and**
- the **declaration** must be signed by a person with parental responsibility for the child; **and**
- this Supplementary Information Form (and any other religious reference statements to be taken into account) must be returned to the School office by **15 January 2024**

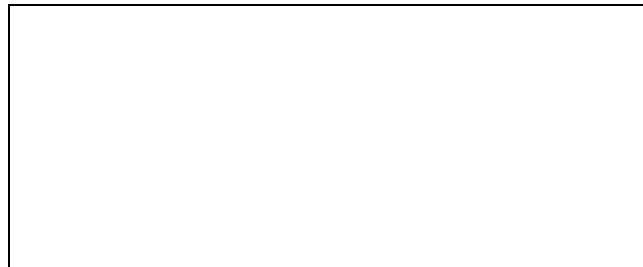
